## An Introduction to Senate Bill 1383

Senate Bill 1383 (SB 1383) is a California law that requires certain businesses to donate all of their excess edible food. One of the goals of this law is to reduce greenhouse gas emissions that result from the decomposition of food waste. Donating food that is still safe to eat can help decrease pollution and feed hungry people.

Businesses considered to be Tier 1 and Tier 2 edible food generators are required to meet certain requirements to be in compliance with SR 1383. Cities may assess a financial penalty.

## **Safe Food Donation Guidelines**



Items past their "best by", "best before", "sell by", "use by" and "freeze by" dates can still be donated, excluding baby food and baby formula.

Cereal	ok!	No!
canned goods & shelf stable items	Unopened or dented	Rusted, bulging or opened
meat & seafood	Unopened  Frozen past the "best by" date	Discolored, moldy or opened  Food that smells "off" or "bad"  Food left out of temperature
dairy items	Unopened and sealed	Opened or unsealed  Moldy or discolored

## Temperature Guidelines

Frozen (32°F or below)	Frozen food, raw meat, seafood
Refrigerated (41°F or below)	Eggs, dairy, cold deli items, precut produce, prepared foods, baked goods with cream or meat
Room Temperature	Baked goods, dry and shelf stable items, whole & uncut produce

## Good Samaritan Laws protect you from liability.



California recently passed the California Good Samaritan Food Donation Act (AB 1219), which provides liability protections for entities that make good faith donations of surplus food. The law clarifies and expands liability protections for donated surplus food by:

- Creating a more comprehensive list of entities covered by the law.
- Providing liability protection for donations made directly to end-users.
- Explicitly stating that donation of past-date food is subject to liability protection.
- Providing liability protection to gleaners.
- Expands liability protection to donations made by food facilities, which are subject to food safety regulations and regular inspections, directly to individuals for consumption (direct donation).

Donors are also protected under the Federal Bill Emerson Good Samaritan Food Donation Act. United State Code, Bill Emerson Good Samaritan Food Donation Act Title 42, Chapter 13A, Section 1791 – (c)(1) states that:

A person or gleaner shall not be subject to civil or criminal liability arising from the nature, age, packaging, or condition of apparently wholesome food or an apparently fit grocery product that the person or gleaner donates in good faith to a nonprofit organization for ultimate distribution to needy individuals.

Donating in good faith? You are protected!

## Food Recovery Agreement (Page 1/2)

This Agreement (this "Agreement") is dated		month	day	year

a food recovery organization ("Recipient	:").			

WHEREAS, in connection with its production activities, Donor has and will have leftover foodstuffs and other consumables (the "Goods"). Donor wishes to donate such Goods to Recipient, pursuant to the terms of this Agreement.

- 1. DONATION; FREE DISTRIBUTION. Donor hereby donates the Goods to Recipient. Recipient represents and warrants that (i) the Goods will be distributed for free to Recipient's clients, (ii) Recipient is a nonprofit organization that is operating for religious, charitable, or educational purposes and does not provide net earnings to, or operate in any other manner that inures to the benefit of, any officer, employee, or shareholder of Recipient, (iii) Recipient is knowledgeable of the standards to properly recondition donated food or grocery products, and (iv) Recipient is not providing anything of monetary value to Donor in consideration of the Goods.
- 2. INSPECTION. Recipient acknowledges inspection of each donation of Goods, and satisfaction with their condition.
- 3. RELEASE. Recipient, for itself and its successors, assigns, agents, employees, and representatives, hereby releases and discharges the Donor, and each of their former, current and future directors, officers, shareholders, predecessors, successors, assigns, affiliates, board members, agents, insurance carriers, attorneys, servants, employees (including without limitation any catering company engaged for the preparation and delivery of the Goods) from each and every claim, cause of action, damages (including consequential damages) and demands, loss and expense, including but not limited to attorneys fees and costs, that it has or might have, in any way arising out of or in connection with this Agreement or the Goods except to the extent that any such liability cannot be released or waived under applicable Federal, state or local law. The foregoing shall, to the fullest extent of applicable law, be in addition to, and not in replacement or substitution of, any legal protections offered by any "Good Samaritan" or other similar laws in any jurisdiction.
- 4. WARRANTY DISCLAIMER. Donor hereby expressly disclaims all warranties, written or oral, statutory, express or implied, including any warranty of wholesomeness, merchantability, condition, quality, fitness for use, or suitability of the Goods in any respect whatsoever, including any warranty regarding the absence of any defects therein, whether latent or patent; it being understood and agreed that the Goods are being donated in their current condition as of the date hereof. In connection with Donor's donation of the Goods, Donor shall in no event be liable for any claim whatsoever by or through Recipient, or any third party, for any issue or problem with the Goods, whether such claim is based in any form of warranty, contract, tort (including negligence), strict liability or otherwise and whether for direct, incidental, consequential, exemplary or other damages, except to the extent that any such liability cannot be released or waived under applicable Federal, state or local law. Donor neither assumes nor authorizes any person to assume on their behalf any liability in connection with the use or reuse of the Goods.

## Food Recovery Agreement (Page 2/2)

5. MISCELLANEOUS. This Agreement and the terms and conditions set forth herein constitute the complete and final agreement between the Donor and Recipient relating to donation of the Goods and supersedes all prior agreements, whether written or oral, relating to the subject matter hereof. No agreement in any way modifying these terms and conditions will be binding upon the Donor or Recipient unless made in writing and signed by a duly authorized representative of each of Donor and Recipient. This Agreement shall be governed by and construed in accordance with the laws of the State of California and applicable federal law (including without limitation the Bill Emerson Good Samaritan Food Donation Act). Recipient shall not use Donor's name or any trademark or reference related to such in connection with the donation, use or disposal of the Goods, without express approval.
